Dear Marshal,

On behalf of the BRSCC East Anglian Centre I would like to extend an invitation to you to marshal at Snetterton with the BRSCC East Anglian Centre and our partners (MSVR, CSCC, HSCC & MGCC) during the forthcoming season.

Enclosed is an Availability Form, a Supplementary Information sheet and a sheet on which you can record the events you volunteer to attend.

It is particularly important that you read the Supplementary Information sheet in conjunction with the Availability Form, as we need positive confirmation that we can hold & process your personal data for the purposes of administering the provision of marshals at the race meetings listed on our Availability Form. This is achieved by you signing & dating your Availability Form in Section D. If you are aged 17 or under, it outlines the requirements for parental consent & supervision to allow you to sign-on as a marshal.

Once completed & signed, please return your Availability Form to me.

You should retain for your reference the sheet on which you can record the events for which you have volunteered, as this also shows the Emergency Telephone Number that can be used to contact me on race days. I would also recommend you retain the Supplementary Information sheet & this letter.

If you are planning to attend our annual Training Day at Snetterton on Sunday January 26, 2020, you should return your Availability Form by January 20, 2020. This is to ensure that we can provide you with the full personal accident cover arranged on your behalf by the Motorsport UK; which includes travel to & from the circuit.

Please can I also remind any marshals aged of 17 or under wishing to attend Training Day that it is essential that you are accompanied by a parent, guardian or a temporary carer. If you are to be accompanied by a temporary carer please contact me in advance of Training Day and I will provide a consent form to be completed by your parent or guardian. Whoever accompanies you must sign on with you and speak to me.

Training Day will be the usual mix of activities and once again there will be outside practical training; so please come prepared! We plan to send out a schedule of the day's activities about a week prior to the Training Day. Lunch will be provided free of charge this year.

If you haven't attended a Motorsport UK sanctioned Training Day at either Snetterton or another race circuit within the past two years, I would strongly recommend that you attend one before the start of the 2020 season to ensure you keep your training up to date.

I recognise that during the year circumstances change and you may no longer be able to attend a meeting you have volunteered for. Should this happen I would very much appreciate a call or email to let me know. Equally if you find you can now attend a meeting, please let me know in advance of the meeting so that the Motorsport UK Insurance can cover you from when you leave home.

On behalf of BRSCC East Anglian Centre can I thank you for your past support and hope that you will continue to support us during the 2020 season.

The following information should be read in conjunction with the BRSCC East Anglian Centre's Availability Form. By signing and returning your Availability Form you are agreeing to these terms & conditions.

Personal Data

- 1. The BRSCC East Anglian Centre collects personal data solely for the purpose of administering the provision of marshals for selected race meetings at Snetterton, as identified on the Availability Form.
- 2. The BRSCC East Anglian Centre will not share your personal data with any person or organisation unless related to Point 1 above. By way of example, but not limited to, in the event of you being involved in an incident or accident we may need to share your data with the race meeting organising club, if it is not the BRSCC East Anglian Centre, representatives of Motorsport UK, Motorsport Vision as the landowner of Snetterton Circuit, and the Police or Local Authority if required.
- 3. The personal data we hold is what you have provided on the paper copy of your Availability Form; we do not collect personal data by any other means.
- 4. By returning your Availability Form you agree to us retaining your personal data on both the paper document and in a secured Microsoft Excel® spreadsheet. Any data that has been previously loaded into the secured Microsoft Excel® spreadsheet has been pre-filled on your Availability Form for you to check & amend as necessary.
- 5. If you have provided an email address as part of your personal data you have agreed to receive communications by email.
- 6. If at any time you wish to check the personal data the BRSCC East Anglian Centre holds on you, please put your request in writing by post to the BRSCC EA Marshals' Secretary, 8 Margaret Street, Walton, FELIXSTOWE, IP11 9EJ or by email to marshals@brscc-ea.co.uk
- 7. If you no longer wish the BRSCC East Anglian Centre to hold any of your personal data please write to the BRSCC EA Marshals' Secretary at the address in Point 6 above. We will then delete your data and you will cease to be notified of the race meetings at Snetterton on our Availability Form or provided with entry tickets for those events.

Parent/Guardian Consent – Additional information if you are aged 17 or under

- 1. Officials aged 17 or under should be aware that they will need to be accompanied by a Parent, Guardian or Temporary Carer, who will have to sign-on with you and ensure that you are adequately supervised throughout the duration of the event.
- 2. If you are not being accompanied by a Parent or Guardian, it will be necessary for the Parent or Guardian to provide consent and nominate a Temporary Carer on a meeting by meeting basis. Forms to provide this consent will be provided by the Marshals' Secretary.
- 3. The BRSCC has a Child Safeguarding Policy, Procedures and Practices which are aligned to the Motorsport UK Child Safeguarding Policy.
