This meeting is organised by the Scottish Motor Racing Club governed by the General Competition Rules of Motorsport UK, incorporating the provisions of the International Sporting Code of the FIA, additional Supplementary Regulations as well as Motorsport UK COVID-19 Guidelines for events and any written instructions the organisers issue for the event including the Knockhill COVID-19 Operations Protocol (Issue 3). Passes: There will be no passes issued for this event. All attendees must be pre-nominated and names will be checked at the entrance. Access will not be permitted to anyone who has not been pre-nominated.

Venue Access: Access will be via the Paddock Entrance. Access to the Paddock Area for Formula Ford teams testing on Friday will be from 8am on Friday 4th June. Teams arriving on Thursday will be held in Paddock 5 overnight. Competitors testing on Saturday may access the Paddock from 8am on Saturday 5th June. Raceday access will be from 6.30am on Sunday 6th June. On Sunday 6th June only personnel nominated during the pre-event sign-on process will be admitted.

Paddock: Please park neatly in the space allocated to your championship / series without wasting space. Private cars and non-essential vehicles should be parked in Paddock 5 (gravel area on the left immediately after entering the Paddock entrance) and not in the main Paddock area. All vehicles and team equipment is left at the owners risk and neither the organisers nor circuit operators can be held liable for any loss or damage, howsoever caused.

Signing On for Competitors: All competitors must complete the self-declaration in advance of the event.

Scrutineering: All competitors must complete the self-declaration in advance of the event.

Drivers Briefings: All drivers must read the Drivers' briefing notes in advance of the event.

Timings: All timings will take place in accordance with the published timetable.

Circuit Access: Access to the Circuit for all sessions will be via the Assembly Area. All cars may be noise tested in compliance with Motorsport UK General Regulation J.5.17-18 prior to being released onto the circuit. Drivers should go to the Assembly Area 15 minutes before published times and then when directed by the marshals they should proceed onto the circuit.

Stop/Go & Drive Through Penalties: The Clerk of the Course reserves the right to impose a 'Stop/Go Penalty / Drive Through penalty' in accordance with Motorsport UK Regulation [Q 12.26].

End of Track Session Procedure: At the end of each track session, all vehicles must slow down and enter the Pitlane following the marshals instructions to return to the Paddock / Parc-Fermé area as required.

Official Notice Board / Information: The organisers will try to run the programme as published, but they reserve the right to delay or bring forward event times to suit the conditions of the day. Copies of practice times & results will be published online at www.smart-timing.co.uk

Protests / Appeals:

Protests and Appeals should be lodged in accordance with Motorsport UK General Regulations electronically via info@smrc.co.uk. All judicial procedures undertaken will be done electronically. Penalties will announced verbally and published electronically on the Official Notice Board.

Awards Presentation: Presentations will be made after each session respecting physical distancing and the Knockhill COVID-19 Operations Protocol.

COVID-19 precautions: Please read and familiarise yourself with the Knockhill COVID-19 Operations Protocol document (Issue 3) prior to attending. Face coverings must be worn by all personnel at all times whilst at the circuit, except when wearing your crash helmet in the car. Physical distancing of minimum 2 metres must be maintained wherever possible and you must remain within your 'Competitor Bubble' at all times, restricted to the driver and their nominated essential team personnel only.
